Antifreeze and Antifreeze Containers (55L or less)

- Antifreeze including ethylene glycol or propylene glycol used as an engine coolant
- antifreeze used for plumbing
- lock de-icing
- gasoline or diesel fuel lines
- Antifreeze containers with a capacity 55 litres or less

Excludes antifreeze or antifreeze containers used for:

- Aircraft de-icing

Filters

- Spin-on or element style filter that is used in hydraulic, transmission or internal combustion engine applications
- coolant filter
- diesel fuel filter used at retail & commercial pump islands
- household furnace fuel filter
- household furnace air filter
- crankcase ventilation filter sock-type filter
- plastic / paper element style filter
- filters for gasoline
- storage tank diesel fuel filter
- sump type automatic transmission filter
- locomotive fuel
- oil / air separator filter

Excludes the following filters:

- air filters

Diesel Exhaust Fluid (DEF) and DEF containers (55L or less)

- Diesel exhaust fluid used to reduce air emissions from a diesel fuel engine
- Diesel exhaust fluid containers with a capacity of 55 litres or less

Other Automotive Containers

- Automotive Aerosols
- Brake fluid
- Conditioners
- Degreasers
- Fuel system cleaners
- Lubricants
- Sealers
- Solvents
- Stabilizers
- Windshield Washer Fluid



Yukon Fee Schedule

In order to assist with the development of the Stewardship Plan, Interchange Recycling has implemented the following Yukon Planning Fee effective July 1, 2024:

- **For lubricating oil** – \$0.02 per litre
- **For filters** – \$0.13 per unit
- **For antifreeze** – \$0.05 per litre for premix and concentrate
- **For containers** – \$0.04 per litre of container size

Payments for 2024 Q3 and Q4 will be due by January 31, 2025.

Implementation Fees will be determined when the Plan is approved by the Yukon Government (anticipated early 2025) and the full requirements are known.
